Attorney Smith introduced redline revisions, and feedback was provided by both committee and non-committee members, prompting discussions and requests for adjustments within the policy framework. Attorney Smith will subsequently distribute a redline draft to all members and non-committee members for further input, with the intention of presenting it for a comprehensive review by the entire board during the May board meeting, with the subsequent vote scheduled for June.
