Electric Heat Pump System: Other	✓	✓	 \$500 Bonus for dual-fuel system, propane only, ducted only. \$500/ton* for new ground source with minimum 3/4 ton. \$250/ton* for replacement ground source with minimum 3/4 ton. *Not to exceed 50% of material cost
Heat Pump Water Heaters	✓	✓	 \$700 for a heat pump water heater. \$50 for standard electric water heater, if fuel switching or if managed through a WiFi enabled smart control or timer.
Electric Thermal Storage (ETS) Heating	√	✓	\$50/kW for ETS heater.
Induction Cooktops/Ranges	√		 Up to \$350 per unit for new construction and gas to electric. Up to \$100 per unit for electric to electric induction.
Timers and Smart Thermostats	√		\$25 per programmable thermostat or timer.\$75 per smart thermostat controlling electric load.
Outdoor Electrical Equipment and E-bikes	✓	✓	25% of the price of an electric bike, snowblower, lawn mower, chainsaw, riding lawn mower (up to \$100-\$250 per item, up to \$1000 for riding mower). Combined maximum rebate \$300 per member per year, riding mower excepted.
Electric Vehicle Chargers	✓	√	 Up to 100% of charger cost (not to exceed \$500).* Up to 50% of plug installation cost (not to exceed \$500).* Rebates for business and public use charging stations also available. *Must program to avoid LPEA peak hours.
Commercial LED		√	For large or small commercial LED lighting retrofit projects and new construction. Amounts vary based on the project. LED-to-LED retrofits do not qualify on commercial LEDs.
All-Electric New Construction Bonus	✓		\$500 bonus to residential members building new all-electric homes or full electric retrofit constuction.
Income-Qualified Weatherization	✓		Funding available only for income-qualified members through existing qualified programs. Contact us for more details.
