COMMITTEE DISCUSSION AND POSSIBLE ACTION

PRESENTATION BY JEFF CHRISTENSEN, CEO ENTRYPOINT NETWORKS -

Christensen discussed the history, evolution, virtues, complexities, and current state of open access networks around the world and in the United States; and how the open access model is overcoming barriers for new internet service providers (ISPs), opening up innovation and competition through local control of infrastructure, and improving the customer experience.

The current manual networks are not designed to support an emerging economy, and network services should be in the cloud and controlled by software. Christensen discussed cost structures and financing through a customer opt-in model and took questions.

POSSIBLE GOALS FOR LPEA – Committee members discussed defining objectives as they consider strategic broadband goal setting that is in alignment with the LPEA mission and vision statements, and as a majority owner of FastTrack Communications. Discussion ensued on motives for assisting the community and LPEA operations and finances; as well as opportunities to increase electricity usage and sales, parameters and methodologies for implementing goals, and prioritization.

DISCUSS BRINGING STAKEHOLDERS INTO PROCESS – The committee discussed meeting with stakeholders and key partners for input on goal shaping, and the efficiency of utilizing consulting services that LPEA currently has on contract; as well as, the six month timeline of the Broadband Committee and how it might not be sufficient to perform its full duty.

FUTURE MEETINGS – Co-Chairman Unger advised that committee members would be contacted to schedule the next LPEA Broadband Committee.

There being no further business, the Broadband Committee of the La Plata Electric Association, Board of Directors meeting adjourned at 2:03 p.m.
