## **BROADBAND PRESENTATIONS:**

Strategic Goals: Fiber Broadband for the LPEA Community: Dr. Timothy Schoechle Basic Infrastructure for Gigabit Fiber to the Home & Premises

Guest speaker, Dr. Timothy Schoechle presented to the Broadband Committee his ideas on strategic goals for fiber broadband within the LPEA community. Dr. Schoechle discussed his basis for economic growth for the community, revenue streams for LPEA, grid management, sustainable energy, community resilience, policy strategy for telecom infrastructure, and the Longmont exemplar. Dr. Schoechle took committee members questions and concerns.

## **FCC AUCTION RESULTS:**

Natambu Obleton, FastTrack Engineer, gave an update on the FCC Auction 904. The FCC Auction 904 ended on December 7, 2020. One provider won the majority share of LPEA's service territory: Rural Electric Cooperative Consortium (RECC). RECC will need to complete the 683 Long-Form by the January 29, 2021 deadline. On the 683 Long-Form, RECC must provide additional information about qualifications, funding, and the network they intend to use to meet their obligations.

RECC was awarded 33% of the rural area maps in Colorado. RECC will have 4 years to cover 40% of the awarded area with service of at least 25 Mbps. RECC is not based in Colorado and has won other auctions around the country. RECC must commercially offer at least one voice and one broadband service to meet the relevant service requirements to all locations within the awarded area and within the allotted timeframe. Mr. Obleton took committee members questions and concerns.
