LPEA REFUNDS \$3.5 MILLION IN CAPITAL CREDITS

In November, you may have noticed a credit on your bill (if less than \$100) or a check in your mail (if more than \$100), from LPEA. This is your capital credit refund for 2020, one of the many benefits of being a member of a rural electric cooperative like LPEA.

In September 2020, the LPEA board approved the retirement of \$3.5 million in capital credits to our members. So, what exactly are these capital credits and how does LPEA determine your refund every year? Here's a quick Q & A.

What are capital credits?

They represent your ownership of



LPEA based on your past electric bill payments. Capital credits should not be confused with profits, which are a return on capital. The retirement of capital credits is a return of memberfurnished capital. Cooperatives exist not to make a profit but to provide affordable electricity.

When do you retire capital credits?

Credits are retired when the LPEA board determines our financial condition allows for it. LPEA retires credits on a 21-year cycle, which means that margins allocated to members in 1998-99 were just retired. This year, LPEA also elected to retire credits that were allocated to members in 2019. This is referred to as a 'LIFO' (last in first out) retirement and it aims to ensure our current membership receives refunds, even if they were not members in 1998-99.

How are my capital credit allocations used until I receive them?

They are used to pay for system upgrades, maintenance, and general operations. If we refunded the total

amount of allocations, we would have to borrow money to continue operating. Having operating capital helps us minimize the amount of highinterest money we borrow, which keeps costs in check.

What happens to my capital credits if I move?

Capital credits cannot be refunded on demand as they are used for long-term investments. Since they are paid years after the credits are earned, always keep us informed of any address and telephone changes so we can continue sending you your refund checks.

Portable Ground Fault Circuit Interrupter (GFCI)

Designed for locations where there is not a permanent GFCI installed, these devices detect an abnormal flow of electricity and shut off the power, preventing shock or electrocution.



Tamper Resistant Outlets (TROs)

Great for families with small children, TROs are wall receptacles that have shutters that stay closed unless a plug with two prongs is inserted into the outlet. They will help keep children safe.

Outdoor Remote Control Outlet Switch

Leaving outdoor lighting on overnight can be costly and pose a potential hazard. An alternative to smart lights, this remote control switch allows you to turn outdoor lights or other gadgets on or off remotely.



Heavy Duty Extension Cord

Powers devices safely. Too often the tools or equipment necessary for larger projects are powered by extension cords that are inadequate for the environment or heavier electrical load.

SMART Girls is the Boys & Girls Club of America's premier girl's leadership program. "Ask questions. Be confident. Stay focused on ethics, the truth, and stay true to your values," she said. "If you're scared, you won't embrace opportunity, and then you won't be the change.

Don't give up, especially when others tell you, you can't."

Kathrene Frautschy, Director of Development at the Club called Jessica a "dynamo" that made a tremendous impact on the girls. "We are so fortunate to have strong female role models like her in our own community, people who care and are making a difference through strong leadership," she said. The participants said of Jessica: "She is a rock star!" At LPEA, we tend to agree.
