GET MONEY BACK IN 2021 WITH LPEA'S REBATE PROGRAMS

With a new year comes new ways to save with LPEA. If you're considering an upgrade or improvement project for your home or business this year, remember you can get money back through the following rebate programs.

Outdoor Electrical Equipment and E-bikes	t đ	25% of the price of an electric bike, snowblower, lawn mower, leaf blower, pruner, chainsaw etc. (up to \$50 - \$150 per item). Combined maximum rebate \$300 per member per year.
Residential Lighting		50% of the cost of LED light bulbs purchased, up to \$8 per/bulb. Maximum 50 bulbs per member per year.
Commercial Lighting		For large or small commercial LED lighting retrofit projects and new construction. Amounts vary based on the project.
Energy Star Appliances	-Energy A	 \$90 per unit for a heat pump clothes dryer. \$30 per unit for a top-load clothes washer. \$40 per unit for a front-load clothes washer. \$30 per unit for an electric clothes dryer. \$30 per unit for a refrigerator or freezer. \$20 per unit for a dishwasher. \$60 per unit for recycling your old refrigerator or freezer.
Electric Heat Pump/ Mini-Split Systems		\$500/ton for units greater than 17 SEER (up to 50% of equipment costs). \$350/ton for units rated from 15 to 17 SEER (up to 50% of equipment costs).
Permanent Electric Heaters		\$30/kW for Electric Thermal Storage (ETS) heater. \$30/kW for Thermal Slab heating.
Energy Efficiency Audit		Up to \$150 for residential audits. Up to \$300 for commercial audits.
Energy Star Air Conditioner Split System	***	Up to \$150 per unit.
Electric Vehicle Charger	[2]ヴ チ]	 FREE use of a Level 2 ChargePoint Flex plug-in charger for home use (\$700 value). Up to \$500 (not to exceed 50%) of electric parts and labor costs to install a suitable EV charging outlet. Up to \$250 for the independent purchase of a Level 2 charger and up to \$250 for its installation (or 50% of material and labor costs).
Electric/Heat Pump Water Heater	0	 \$700 for fuel switching from propane or natural gas, and providing data to LPEA. \$550 for standard electric water heater to heat pump water heater. \$75 for electric water heaters with lifetime warranty. \$55 all other electric water heaters with a 6-yr warranty.
Low Income Weatherization	\mathbf{A}	Funding available only for low-income members. Contact us for more details.

It's time again for LPEA director elections! In accordance with our bylaws, four of LPEA's Board of Directors seats are up for election annually – one in each district. The board sets LPEA's strategic direction and establishes policy. If you want to get more involved in your local nonprofit utility, we encourage you to apply.

In mid-February, LPEA will post the 2021 Board Candidate Packets on our website. Interested candidates must complete the application materials and return to LPEA by the deadline listed. Qualified candidates will be added to the official ballot sent to all LPEA members in mid-May.

Election results will be announced during a partial virtual Annual Meeting on June 17th, 2021. Given the concerning and unpredictable impacts of the COVID-19 pandemic, the date for the business portion of the 2021 LPEA Annual Meeting will be set later this year.

To be eligible to run for the LPEA Board of Directors, candidates must:

- be a member of LPEA for at least one year immediately prior to becoming a director;
- be a bona fide resident of the district you plan to represent for at least 120 days prior to becoming a director and;
- not be employed by, or have a spouse or child employed by, LPEA in any position.
