Election of Directors

Pursuant to LPEA bylaws, one-third of the director's seats are up for election annually, one in each of LPEA's four districts. The following candidates have been nominated by petition for a three-year term representing:

> <u>District 1</u> (Archuleta County): Holly Metzler, Michael Whiting

District 2 (south and west La Plata County): Dan Huntington (incumbent), Jeff Mannix

District 4 (north and east La Plata County): Sarah Ferrell, Jack Turner (incumbent)

The election in representative District 3 (City of Durango) has been cancelled due to only one nominee in the district: Joe Lewandowski.



La Plata Electric Association has four director districts, established geographically, and each district is represented by three directors, resulting in a full board of 12. Annually, one seat in each district is up for election. LPEA members vote for the director candidate in their district. The enclosed ballot includes the candidates running in your district, based on your electric service address.


