10 YEAR FORECAST AND 2020 BUDGET – Monica Rodriguez led a discussion on the history of LPEA's Operating Margins in relation to Revenue, Cost of Power, and Expenses; the 2020 Budget Overview and Base Case Assumptions; Benchmarks and Revenue Requirements; 10-Year Forecast Assumptions; and 2020 rate increase scenarios and their effect on a long term Budget.
