### How to Apply:

To be eligible for a maximum rebate of \$150 for residential unit audits, or \$300 for commercial establishment audits:

- 1) Select a Residential Services Network (RESNET) or Building Performance Institute (BPI) certified rater to complete your home energy audit.
- 2) Submit:
  - a) This application
  - b) A copy of the audit (must have been completed after Oct. 15, 2014)
  - c) An invoice for the audit
  - d) Receipt showing completion of one of the energy efficiency measure audit recommendations
